Timing:- Eligible candidates are required to report for the Interview at 9:00 A.M on 23.04.2019. Candidates reporting after 10:00 A.M will not be entertained. The eligible candidates may appear before the Selection Committee for interview on the date and time mentioned above at CSIR-Central Drug Research Institute, B.S. 10/1, Sector 10, Jankipuram Extension, Sitapur Road, Lucknow-226031. **Eligible candidates must bring with them a duly filled application (which can be downloaded from our website www.cdri.res.in), with original & attested copies of mark sheets/certificates etc. along with a recent passport size photograph.**

1. सीएसआईआर/वित्तीयन अभिकरण के दिशा-निर्देशों के अनुसार अनु0जाति/जनजाति/अ0पि0 वर्ग/पी0डब्ल्यू0डी0 और महिला अभ्यर्थियों को आयु में छूट दी जायेगी।
2. उपर्युक्त अभ्यर्थियों को भविष्यगत आवश्यकताओं हेतु, यदि कोई हो तो इम्पैनल किया जा सकता है।
3. आयु/अर्हता एवं अनुभव निर्धारण की तिथि साक्षात्कार की तिथि होगी।
