Required an Ad hoc Assistant Professor (two posts) for School of Health Systems Studies

It has a strong M.Phil/Ph.D programme. A high degree of freedom and autonomy shape the positive work ethos and creativity in the Institute. The TISS offers a very challenging but fulfilling academic environment and opportunities to scholars committed to creating a just society through education, generation of knowledge and field action.

The School offers Master's Degree, M. Phil, Ph. D and Executive Diploma programmes, conducts its research, capacity building, advocacy etc. in the field of **Health Systems Studies** through its four centres.

- 1. Centre for Health and Social Sciences (CH&SS)
- 2. Centre for Health Policy, Planning and Management (CHPP&M)
- 3. Centre for Hospital Management (CHM)
- **4.** Centre for Public Health (CPH)

The School invites interested scholars located within and outside India to apply for **Two positions of Assistant Professors** for its two centres viz., one in **CH&SS** and one in **CPH**. The posts will be on contract basis initially for a period of one year and extendable based on performance of candidate and requirement by the Institute. The selected candidate should work as per the job descriptions and guidelines provided by the Centre. He/She should work on various assignments including teaching, guiding students, research, field supervision of Masters' Degree and Executive Diploma Programme students.

Pay Scale: Consolidated Salary of Rs. 71952/- p.m.

Eligibility Criteria:

Educational Qualification: Eligibility (A or B):

A.

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in **Public Health**, **Health Administration**, **Hospital Administration**, **Economics**, and **Population Studies**, **Health and Social Sciences**, **Statistics**/

Bio-Statistics from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree **in the relevant discipline** in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. Candidates shall be exempted from the requirement of NET /SLET /SET for recruitment and appointment of Assistant Professor subject to the or equivalent positions in Universities/Colleges/Institutions fulfilment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- e) The candidate has presented at least two papers based on his / her Ph.D. work in conferences / seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Desirable qualification:

Ph. D. and/or Two years of Teaching experience in the relevent discipline.

Last date of Receipt of Application: June 15, 2020

Interview: The eligible candidates will be communicated by an e-mail and mobile phone to appear for the presentation and interview to be conducted at TISS, Mumbai.

Application fee: The application fee of Rs. 1000/- be paid on-line. The SC/ST/PWD candidates will have to pay an application fee of Rs. 100/- if they attach the required certificate to the online application form. The application will be considered valid only on receipt of the application fee. Fees once paid shall not be refunded under any circumstances.

Other Conditions:

- The Institute reserves the right to relax qualification of the candidate based on the work experience.
- The institute reserves the right to invite persons for interview who may not have applied for as per the above procedure and not fill up the vacancy advertised.
- Since applications received may be short listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.
- The post is unreserved, but candidates belonging to reserved category can apply.
- No queries or correspondence regarding issue of call letter for interview / selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.
- The candidate under employment must bring 'No Objection Certificate' from their employer to appear for presentation/ interview.
- No TA / DA is payable for appearing for the interview.
