
**No. 3/3-116/2018:** In pursuance of the Department of Higher and Technical Education, Government of Manipur letter no. 7(2)/5/2018-HE (VAP) (Pt.) dated 26.03.2021, applications are invited for appointment of suitable candidates to 145 (one hundred forty five) posts of Assistant Professor on **contract basis** for a term of one year/one academic session for the Government Colleges of Manipur as detailed below:

**2. ELIGIBILITY:**

A. Candidates possessing the following qualifications in their respective subject/discipline are eligible for application for the posts except for Assistant Professor in Hindi for Hindi Teachers Training College (HTTC):

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the

grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET :

*Provided*, the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

*The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.*

**Note:** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai

- B. A candidate desirous of applying for the post of Assistant Professor in Hindi for Hindi Teachers' Training College (HTTC) should possess the following qualifications:
- i. Master's Degree in Hindi from a recognized Institute with a minimum of 55% marks;
  - ii. M.Ed. or Hindi Shikshan Nishant after B.T./B.Ed./Hindi Shikshan Parangat from a recognized University/Institute with a minimum of 55% marks;
  - iii. NET/SLET/SET or Ph.D. awarded in accordance with UGC Regulations, 2009.

**N.B:**

- i. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- ii. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.

**3. AGE LIMIT & OTHER ELIGIBILITY CONDITIONS:**

- i. The age limit for the applicants may be fixed as per State Government norms i.e. 18 years to 38 years. The upper age limit may be extended by 3 years in case of OBC Candidates and by 5 years in case of SC/ST Candidates. Upper age for the candidates who are serving in the state Government may also be relaxed to the extent of the period of continuous service put in the post/service. A Government servant who belongs to OBC/SC/ST will get the facility admissible to a Government servant in addition to relaxation admissible to OBC/SC/ST categories
- ii. The candidate must be a permanent resident of Manipur, provided that a candidate whose parent or any of his/her ancestors in his/her direct lineage are permanent resident of the State, with proper documentary proof like enrolment in the electoral roll and birth certificate will also be eligible.

The candidates will be shortlisted as per the criteria given under UGC Regulations, 2018:


