Any subsequent revision in the rate of honorarium shall be applicable only after a decision to this effect is made by the Mizoram University.

Conduct of the interview and/or engagement as Guest Faculty shall be subject to the actual requirement of the University from time to time. Interview, if scheduled is likely to be held at short notice and in online/offline/blended mode depending upon the prevailing pandemic situation. - 2. Candidates are advised to satisfy themselves before applying that they possess at least the minimum essential qualifications, furnished with clarity, as laid down in the advertisement.
- 3. Applications should be supported by relevant documents in all respects. Claims of educational qualifications should be supported by Certificates/Marksheets.
- 4. Application after the last date, incomplete in any respect and any fresh paper/enclosures after the closing date, shall not be considered. Canvassing directly or indirectly at any stages of the process will lead to disqualification.
