1. **Age limit:** Maximum age is 35 years for JRF/SRF and 21-45 years for Young Professional-1 (age relaxation of five years for SC/ST & women and three years for OBC).
2. The emolument of JRFs and YPI will be as per CSIR/ ICAR rule and Delhi Govt. approved rates.
3. The above posts are purely temporary, time bound and co-terminus with the project. Appointment will be yearly based on the progress and fund availability.
4. The selected candidates shall not claim for regular appointments at the Institute as the position is co-terminus with the project.
5. The Interview of eligible candidates will be held according to schedule given above.
6. The candidates will have to compulsorily bring the filled in application form (as per the format annexed), all the original certificates from matriculation onwards, date of birth certificate, NET/equivalent certificate, degree certificate either original or provisional and one set of the self-attested photocopies of all the required certificates from matriculation onwards and an attested copy of recent passport size photograph pasted onto the application form. Proof of experience and publications also need to be submitted.
7. No TA/DA will be paid for attending the interview.
8. Only the candidates having essential qualifications would be interviewed.
9. **Concealing of facts or canvassing in any form shall lead to disqualification or termination of such candidates.**
