Important Instructions:

1]	The Application Form, Prescribed Form for Medical certificate, Recruitment Rules and Instructions to fill up the form can be downloaded from University website www.nau.in
2]	Candidate's name in application and in the documents should be the same. Legal documents should be attached, if it is not the same.
3]	This Advertisement is open for the Physically Disabled candidates of the entire category (i.e. Gen/SC/ST/EWS/SEBC) etc.
4]	Medical Certificate should be submitted in the prescribed proforma as per the Appendix-A of Vernacular Circular No. ૫૨૫/૧૦૨૦૦૮/૪૬૮૫૪૦/૧.૨ દા.૦૧/૧૨/૨૦૦૮ of Gujarat Administration Department, Gandhinagar.
5]	The Physically disabled candidates who have applied in the Part-A of Advertisement No.1/2018 are exempted from the application fees only. But they have to submit the application form with necessary documents as per this advertisement in stipulated time limit.
6]	Age relaxable in case of Physically Disabled and WOMEN will be applicable as per State Agricultural Universities of Gujarat (SAU's of Gujarat) statutes and guidelines of Government of Gujarat from time to time.
7]	New defined contributory pension scheme as introduced vide Government vernacular Resolution Dated: 18-3-2005 and 6-6-2005 No. NPN-2003-GOI-10-P will be applicable in case of candidates other than Gujarat Agricultural Universities employees and those who are recruited after 1-5-2005.
8]	The Application fee Rs. 250/- should be filled by Demand Draft of State Bank of India in favor of "ACCOUNT OFFICER (CASH), NAVSARI AGRICULTURAL UNIVERSITY, NAVSARI " .
9]	The application once submitted, no additional document will be accepted thereafter.
10]	The post of Physically Disabled will be filled up as per State Government rules. The relaxation in age also will be given as per rules of Government of Gujarat
11]	The University shall verify the antecedents or documents submitted at any time, at the time of appointment or during the tenure of the service. In case, it is found that the documents submitted are fake or the candidate has clandestine antecedents /background and has suppressed the said information, his/her service shall be terminated forthwith.

12]	For the candidates having Master's degree, NET shall remain compulsory along with one publication in NAAS rated referred journal for recruitment to the post of Assistant Professor and its equivalent in the disciplines in which NET is conducted by ICAR/UGC/CSIR. Essentiality of NET can be waived off for the candidates holding Ph.D degree provided it has been done with course work and research work prescribed by the UGC Regulations 2009 and the candidate has at least two full length publications having a NAAS rating not less than 4, on the last date of submission of application. Those candidates with Ph.D degree without course work will not qualify for NET exemption. NET Certificate (complete i.e. with instructions in part) to be submitted.
13]	The candidate having Ph.D Degree prior to 2009 without course work shall be eligible when he/she produce certificate from concerned University as per the UGC Regulations-2009.
14]	Probation period shall be of two years .
15]	Envelope containing the application should be subscribed as ' APPLICATION FOR THE POST OF _____ (DISCIPLINE: _____)
16]	The application along with attested copies of certificates, pertaining to the qualifications and experience accompanied with the demand draft of the State Bank of India should reach to the Registrar, Navsari Agricultural University, Navsari on or before closing date i.e. 09-06-2022 The applications received after the last date shall stand rejected automatically. No intimation in this regard will be communicated to candidates.
17]	Application in the prescribed proforma, available on web site, should be filled in completely supported with attested copies of certificate pertaining to the qualifications and experience, accompanied with crossed Demand Draft of Rs. 250/- (Non refundable) in favour of " ACCOUNT OFFICER (CASH), NAVSARI AGRICULTURAL UNIVERSITY, NAVSARI ".
18]	The Summary Form should be neatly filled in and to be enclosed with the application in ten copies compulsory.
19]	Eligible candidates will be informed about date and place of interview by post/ e-mail/ SMS. The candidates must write his/her e-mail ID, Mobile number. However, University does not take any responsibility for intimation about interview. List of eligible candidates and the dates of interview would also be displayed on the website of the University. (www.nau.in)
20]	All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess, at least the essential qualifications prescribed for the post. No enquiry or advice as to the eligibility will be entertained.
21]	Candidate must bring all the original documents at the time of interview. Non-production of original certificates will result to disqualification.
22]	The service conditions will be governed by the University Acts, Statutes, Rules and Regulations framed and amended by the University/ Government of Gujarat from time to time.
23]	No TA and DA will be paid for appearing in the interview even if any interview is not held on scheduled date due to one or the other reasons.
24]	<u>The University reserves the right to withdraw the posts without any intimation at any point of time.</u>
25]	Employee is transferable within the jurisdiction of Navsari Agricultural University as per University requirement.
26]	The applications (both "advanced copy" and copy through proper channel) may reach to the office of the Registrar, NAU, Navsari either in person or by post or by courier on or before the prescribed dates. The University will in no case be responsible for non-receipt of application(s) or any delay in receipt thereof on any account whatsoever. It is also stated that no application will be considered after the prescribed closing/last dates and late application will be rejected, without any notice. It is therefore, emphasized that candidate(s) should ensure that his/her/their application(s) reach to the <u>Registrar, Navsari Agricultural University, Navsari</u> on or before the prescribed closing/last date(s). For

	application through proper channel, the candidates are advised to submit application (complete in all respect) before the closing date. However, application through proper channel must reach within fifteen days of the closing date. <u>SUCH APPLICATION RECEIVED AFTER PERIOD OF FIFTEEN DAYS SHALL NOT BE CONSIDERED FOR INTERVIEW.</u>
27]	Instead of furnishing information in the space provided for in the application form, while some candidates furnish information besides appending documents/enclosures in addition to the prescribed ones, which makes the applications unnecessarily bulky. Therefore, the candidates are advised to fill the application in the prescribed format and that too <u>only</u> in the space provided for in the application form, and not to resort to annexure except only the prescribed documents/ certificates, i.e. photocopies of date of birth/ M.Sc./Ph.D/Physically Disabled certificate.)
28]	Copies of Date of Birth, B.Sc./M.Sc and Ph.D Mark sheet, degree certificates and notification. (SEBC/EWS/SC/ST/ Physically Disabled candidates need also to enclose self attested copy of the certificate issued by the competent authority in this regard).
29]	Photographs at the appropriate space(s) in the application form to be pasted
30]	Canvassing in any form will disqualify the applicant/candidate.
31]	In case of any discrepancy, English version of the detailed advertisement appearing in websites will be treated as final.
32]	The crucial date for determining the eligibility in respect of Age/Educational Qualifications/ Experiences will be last date of application i.e. date; 09-06-2022
33]	The University reserves its right not to fill-in all or any post if deems necessary. Any postal delay in receipt of applications will not be considered.
34]	Recruitment rules of Assistant Professor & its equivalents will be as per the Statute of SAU's of Gujarat.
35]	The certificates/ documents must be submitted in English, Hindi or Gujarati language.

Recruitment Rules for the Post of ASSISTANT PROFESSOR & ITS EQUIVALENT

Prescribed Qualifications :

i)	Good academic record with at least 55% of marks or an equivalent grade at the Master or Doctorate level degree in the relevant subject of concerned faculty from recognized university.
ii)	The candidate should have passed NET examination conducted by UGC/CSIR/ICAR/ NET recognized by the State Government in the subject, where NET examination is conducted and should have published at least one article in National Academic of Agriculture Sciences (NAAS), New Delhi rated journal. But, candidate who has acquired Ph.D degree with course work as per the UGC Notification, 2009 and published two full length publication heaving a NAAS rating not less than four shall be exempted from NET on the last date of submission of application. Those candidates with Ph.D degree without course work will not qualify for NET exemption.

Other qualification:

a)	The candidate should process the basic knowledge of computer application and should have passed CCC+ examination, he will have to pass the same during the probation period, failing which his probation period will not be regularized.

Relaxation:

a)	NET/SLET/SET shall not be required for such subjects for which NET/SLET/SET accredited test is not conducted.
b)	For the purpose of eligibility and for assessing good academic record during direct recruitment, a relaxation of 5% at the Graduate and Master's level for the SC/ST/ Differently-abled (Physically and visually differently- abled) categories of the candidates.
c)	The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks excluding grace marks if any.
d)	A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D degree holders, who have obtained their Master's degree prior to 19 th September, 1991.

Maximum Age Limit : Below 35 Years

i)	Age relaxable in suitable cases of the employees of the Gujarat Agricultural Universities.
