- For the post of Chair Professor and Assistant Professor, the University will follow the "UGC Regulations on Minimum Qualifications for the Appointment of Teachers and Other Academic Staff in University and Measures for the Maintenance of Standards in Higher Education 2018 and Notifications, Notice and Circulars issued by the UGC in this regard from time to time.
- Dr. Ambedkar Chair has been sanctioned by Dr. Ambedkar Foundation, Ministry of Social Justice and Empowerment, Govt. of India, New Delhi on full time basis (term based) and

will be initially for five years, which may be extended.

MINIMUM QUALIFICATION:

1. For the post of Chair Professor:

- (A) (i) An eminent scholar with Ph.D. qualification(s) in any relevant subject with the specialization in Social, Economic and Cultural Issues and the Thoughts of Dr.

 Ambedkar / Dalit or Tribal Literature / Social Justice and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in the Appendix II, Table 2.
 - (ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institution with evidence of having successfully guided doctoral candidate.

OR

(B) An outstanding professional, having Ph.D. Degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above)/ industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

2. For the post of Assistant Professor:

- (A) (i) A Master's degree with 55 % marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
 - (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./ Ph.D. Degree) Regulations, 2009 or 2016 and their amendments fromtime to time as the case may be (exempted from NET/SLET/SET).

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinance/Byelaws/Regulations of the Institution awarding the degree and such Ph.d. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in University/Colleges/Institutions subject to the fulfillment of the following conditions:

- a. The Ph.D. Degree of the candidate awarded in regular mode only;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;

- c. An open Ph.D. viva voce of the candidate had been conducted.
- d. The Candidate has published two research papers from his/her Ph.D. work, out of which at least one must be in a refereed journal;
- e. The Candidate has presented at least two papers based on his/her Ph.D. work in conference/seminars sponsored/funded/supported by the UGC/ ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the registrar orthe Dean (Academic Affairs) of the University concerned.

Note:

NET/SLET/SET shall also not be required for such Masters Programmesin disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

(iii) All research publications mentioned in the application form must be in the field of Social, Economic and Cultural Issues and the Thoughts of Dr. Ambedkar / Dalit or Tribal Literature / Social Justice in the peer-reviewed or UGC-listed journals.

OR

(B) The Ph.D. degree has been obtained from a foreign university/institutions with a ranking among top 500 in the World University Ranking (at any time) by anyone of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

GENERAL CONDITION & ESSENTIAL INFORMATION

- 1. As far as possible preference may be given to the persons belonging to SC, ST, OBC or those belonging to other Weaker Sections of the Society in the selection of above posts.
- 2. Applications incomplete in any respect and not accompanied with relevant certificates/documents/photographs/copies or orders etc., as desired or without requisite fee will be summarily rejected.
- 3. Candidates are advised to satisfy themselves before applying that they possess essential qualifications laid down in the advertisement.
- 4. Candidates already in employment would be required to submit their application through proper channel, failing which they may not be considered. However, they may send an advance copy and produce 'No Objection Certificate' at the time of interview.
- 5. Mere eligibility will not entitle any candidate for being called for interview. Applicants having higher qualification and merit will be given preference.
- 6. The candidates will be called for interview, wherever applicable, by the University on the recommendations of Screening-Cum-Scrutiny Committee.

- 7. Experience and qualification will be reckoned as on the last date of submission of online application.
- 8. The service conditions including AGP and GP and age of superannuation shall be as per UGC/University Rules/Norms.
- SC/ST and PWDs Candidates must enclose with application the hard copy of the Caste Certificate/Medical Certificate in GOI prescribed format duly issued by the competent authority.
- 10. OBC (Non-creamy layer) Candidates are required to submit a certificate in a prescribed format duly issued on or after 01-07-2016 by the competent authority. To avoid delay in submission of applications, OBC candidates are allowed to apply with their OBC certificate issued before 01-07-2016. Such candidates shall be required to produce the updated OBC Certificate at the time of interview.
- 11. The University shall verify the antecedents or documents submitted by the candidate within three months of the joining. In case, it is detected at any time that the documents submitted by the candidates are fake or the candidate has clandestine antecedents / background and has suppressed or altered the said information, then his/her services shall be terminated immediately and appropriate action shall be initiated as deemed fit.
- 12. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves right to modify/withdraw/cancel any communication made to the candidate.
- 13. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
- 14. Candidates must enclose self-attested copies of certificates and mark-sheets from matriculation (10th Standard) onwards in support of their qualifications and reprintsof publications and certificates in support of their claim for the post along with the application form.
- 15. Canvassing in any form will be a disqualification.
- 17.No interim correspondence shall be entertained.
- 18. In case of any dispute, suite or legal proceedings against the University, the jurisdiction shall be restricted to the Hon'ble High Court of Madhya Pradesh, Jabalpur.
- 19. The service contract may be terminated at any time with one month's prior noticeby the university or one month salary may be paid in absence of notice without assigning any reason. The candidate is also required to give one month's advance notice or else deposit one month's salary; in case the candidate is leaving during the contract period.
- 20. After joining the positions under Dr. Ambedkar Chair, the candidates will have to abide by the Rules, Regulations and Ordinances of the University/Rules of UGC/Rules of Govt of India applicable from time to time. S/he may be assigned any duty within/outside the University depending upon the exigencies of the work.

- 21. The appointment is purely on deputation/contractual basis. It will not give any right for a regular appointment.
- 22. The selection procedure for Chair Professor and Assistant Professor shall be as laid down by the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic staff in Universities and Colleges and Measures for maintenance of Standards in Higher Education, 2018 and as amended from time to time.
- 23. A Relaxation of 5% may be provided for the teaching posts at the Graduate and Master's level for the SC/ST/Differently-abled (Physically and Visually differently-abled)/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark.
- 24. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. degree holders, who have obtained their Master's Degree prior to 19th September, 1991.
- 25. Candidates awarded degree by Foreign Universities are required to submit Equivalence Certificate issued by Association of India University, New Delhi.
- 26.
